

### **Guidelines of Synopsis Submission for Ph.D. Degree**

This document provides guidelines for preparing a research synopsis and indirectly final report of your work that will be presented at the end of your research program. The primary objective of the synopsis is to enable the reader to judge whether a prima facie case exists for accepting the proposed Ph.D. thesis for the award of the Ph.D. degree. The synopsis should therefore, list, clearly, the contributions resulting from the investigations carried out by the candidate, which have led to advancement of knowledge in the field of investigation. In order to fully appropriate the candidate's contribution, it is necessary to put it in a proper context.

The synopsis is to be considered as a detailed summary of the work with important results highlighting the original contributions in the thesis to be submitted. It should give an outline of the thesis. The review of earlier work is to be minimized with just enough to highlight the contributions in the research work to be reported in the thesis. It is expected that at the time of submission of the synopsis no work is yet to be completed except detail writing of the thesis and all other academic requirements such as course work, comprehensive examinations/RDCs and the suggestions and directions given by members of the Doctoral Committee have been fulfilled.

#### **Eligibility to submit the synopsis:**

- 1. Coursework should be clear.
- 2. Two research paper publication (ISSN/ISBN) related to Ph.D. topic with guide and Swarrnim Startup & Innovation University (SSIU) name. (at least one publication must be Scopus/WoS indexed)
- 3. Minimum four RAC should be cleared. (Recommendation by RDC panel to submit the synopsis)

4. Two paper presentations related to Ph.D. topic should be presented in conferences or public seminars

#### Note:

- Research scholar has to send the PDF file of synopsis via mail prior to one month of submission/presentation of synopsis.
- Duration between RAC and Synopsis would be six months.
- The synopsis should be duly signed by guide.
- Eligibility certificate should be provided by the scholar before submission/presentation of the synopsis (Annexure B).
- After approval of synopsis, University will conduct pre-thesis presentation within 2-6 months followed by thesis submission.
- Research scholar has to reappear for synopsis presentation after six month in case of synopsis not approved.

	LENGTH OF SYNOPSIS: Whilst the regulations do not contain a clause relating to the		
	maximum length of synopsis, it is expected that work presented for the degree of Ph.D		
	should normally between 40-50 pages (excluding references). Candidates wishing to		
	greatly exceed these sizes should discuss the matter with their supervisors.		
	<b>PLAGIARISM:</b> All the work should be plagiarism free. A Synopsis depicts a very smal		
	representation of Main Thesis hence it is always not possible to verify the exac		
	percentage of plagiarism in a synopsis. Every Research Scholar is advised to first check		
	his / her thesis with any reputed anti-plagiarism software such as 'Turnitin', 'Urkund		
	(Provided by INFLIBNET)'. It is recommended that a similarity index less than equal to		
	20% (<=20%) will be required (25% for the chapter of introduction and literature review).		
	<b>COPIES:</b> Four spiral copies and one CD		
	SIZE OF PAPER. A4 size he used no restriction is placed on drawings and mans		

□ LAYOUT OF SCRIPT: Typescript should appear on one side only, lines; at least one - and-a-half spaced. Quotations, references and photographic captions may be single spaced. Where appropriate, these should contain lists giving the locations of figures and illustrations.

REFERENCES: Text of the manuscript should have proper citations wherever necessary. Synopsis must contain latest references. References must follow APA style for Humanities/ Management, MLA style for Literature, and IEEE style for Sciences/Engineering. The listing of references should be typed in alphabetical order of the first author's name In single spacing starting 4 spaces below the heading REFERENCES in Times New Roman with font size 14 bold There are several standards for referencing. E- Resources should have their proper URL mentioning the date and time of access. A candidate may choose one of his/her choice with the consent of the thesis supervisor(s) and should be consistent throughout.
